## The Parents/Person with Parental Responsibility

We will do our best to:

- Encourage our child to be as independent as possible when managing their daily routines.
- Encourage our child to be a polite, caring and friendly member of the school.
- Support our child in every opportunity for home learning.
- Let the school know about any concerns that might affect our child's work or behaviour.
- Support the school's behaviour management strategies and help to maintain high standards in all areas.
- Ensure that we do not use social media to publish photos of school events.
- Ensure any concerns or queries about the school are addressed directly to the school and not through social media.
- Ensure that our child arrives at school on time between 8.25-8.40am, properly equipped, dressed appropriately and attends regularly.
- Ensure our child is collected promptly at 3pm, or promptly following an after-school activity.
- Ensure that our child stays with their responsible adult whilst on the school premises and does not use school equipment after hours.
- Ensure we contact the school by 9.00am if our child is ill and provide an explanatory note.
- Ensure monies are paid promptly.
- Keep Arbor updated with changes of emergency contact numbers and any changes to drop off/collection personnel.
- Ensure that we keep the school fully informed of any medical conditions our child has.
- Ensure that our child is not taken out of school in term time except in very exceptional circumstances.
- Reply to any school correspondence.

- Keep a Care Plan for pupils with medical conditions and keep parents fully informed.
